# **Faith Valley Restoration Planning**

On February 25, AWG staff participated in a Faith Valley Conceptual Design Review Webinar hosted by American Rivers. Twenty stakeholders met virtually to learn about the baseline conditions assessment and the draft conceptual design report produced by Waterways Consulting. American Rivers has identified Faith Valley as a priority meadow for restoration because of channel incision and

other impairments. Several large, stable beaver dam complexes have helped to keep the meadow intact but have had trouble persisting long enough to provide long-term restoration outcomes.

To assess the current conditions, consultants performed a topographic survey, created a geomorphic map, conducted a botanical survey, inventoried beaver dams, and completed an assessment of the adjacent off-highway vehicle (OHV) road. The draft conceptual design proposes constructing beaver dam analogs, a light-handed approach that includes installing structures that mimic natural beaver dams, with the goal of aggrading the channel-raising the channel level by encouraging sediment to be deposited. Raising the channel bed will help to reconnect the stream to its floodplain and will provide habitat benefits for fish and birds. The draft design also includes a number of upgrades to the road and possibly a trail to reduce erosion, address drainage issues, and improve the recreational and aesthetic value of the meadow.

## **Keeping Alpine County Fire** Safe

At the March AWG meeting, the Alpine Fire Safe Council (AFSC) will lead a question and answer period on the Community Wildfire Protection Plan and the Adjacent Lot Ordinance. In preparation for this discussion, here is some background information.

The purpose of the **Community Wildfire Protection Plan** is to provide descriptive elements to help residents improve and implement wildland fire measures to protect their home and property from wildland fire. By implementing the plan elements, your home can be better protected from a wildland fire. The plan also



suggests a neighbor-to-neighbor strategy which can assist firefighting and, quite possibly, save homes and lives. The first section of the plan is the Executive Summary, providing an overview of the elements of the plan. You can review the plan here. It is also available at the Alpine County Library in Markleeville.

The Adjacent Lot Ordinance is an adjunct to the County Vacant Lot Ordinance. In short, the Adjacent Lot Ordinance is predicated to function solely on a complaint basis. There are many vacant lots in the inhabited areas of Alpine County; most are unattended and overgrown, presenting an extreme wildland fire hazard to both residents and firefighters. The AFSC, the Fire Chief, and the Alpine County Board of Supervisors worked on this ordinance adjunct to address the ever-growing problem of unattended vacant lots. Reference to this ordinance can be found in Alpine County Vacant Lot Ordinance Chapter 8.20-Fire Restrictions and Fuels Reduction.
